

Terms and Conditions

ENTIRE AGREEMENT: This agreement contains the entire understanding between Wedding Diary and the CLIENT. It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing, signed by all the parties. If the parties want to waive one provision of this agreement that does not mean that any other provision is also waived.

RESERVATION: A signed contract and reservation fee are required to reserve the specified coverage. Upon your signature (For office booking agreement Signature, For Online Booking Agreed with Terms & Conditions) Wedding Diary Bangladesh will reserve the time and date agreed upon. For this reason **the Reservation Deposit of 50% of package price is nonrefundable**, even if the date is changed or the event cancelled for any reason, including acts of God, fire, strike and/or extreme weather. The Reservation Deposit is to be paid at time of signing the contract. Balance Payable when you receive soft copies.

PRE-EVENT CONSULTATION: The parties agree to a pre-event consultation two to three weeks before the event date in order to finalize the actual shooting times, locations, and CLIENT'S request list (in writing) for specific photographs. The bride and or groom agree to set aside at least one hour of time that ends 1/2 an hour before the ceremony commencement of the wedding and a 30-minute time frame afterward for photographs that cannot be obtained during the wedding. If the bride's or groom late arrival prevents a full hour from occurring the photographer shall not be held liable for failure to take desired photographs.

CO-OPERATION: The parties agree to cheerful cooperation and communication for the best possible result within the definition of this assignment. Wedding Diary recommends that CLIENT designate an "event guide" to point out important individuals for informal or candid photographs to the photographer during the wedding that they wish to have photographed. The photographer will not be held accountable for not photographing desired people if there is no one to assist in identifying people or gathering people for photographs. Wedding Diary is not responsible if key individuals fail to appear or cooperate during photography sessions or for missed images due to details not revealed to Wedding Diary.

SHOOTING TIME / ADDITIONS: The photography schedule and selected methodology are designed to accomplish the goals and wishes of the CLIENT in a manner enjoyed by all parties. CLIENT and Wedding Diary agree that cheerful cooperation and punctuality are therefore essential to that purpose. Shooting commences at the schedule start time.

HOUSE RULES: the guidelines of the ceremony official or reception site management limit the photographer. CLIENT agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for moderation of guidelines is Client's responsibility. Wedding Diary will offer technical recommendations only.

COPYRIGHTS: Until final payment for services rendered is made, the photographs produced by Wedding Diary Bangladesh are protected by Copyright Law (all rights reserved) and may not be reproduced in any manner without Wedding Diary's explicitly written permission. Upon final payment by the CLIENT, limited copyright ownership of the resulting images will be transferred to the CLIENT under the following Conditions: The Digital Copies are the property of CLIENT for personal use and for the purposes of the reproduction and giving of photographs to friends and relatives. The Client must obtain written permission from and compensate Wedding Diary prior to the CLIENT or its friends and relatives publishing or selling the photographs for profit.

EXHIBITION: Requests for specific negatives or slides to be used by Wedding Diary may be requested at a future time. CLIENT grants Wedding Diary's permission to display selected images resulting from this assignment as an example of Wedding Diary work and for entrance into photographic competitions and release all claims to profit that may arise from use of images.

MODEL RELEASE: The CLIENT hereby grants to Wedding Diary and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of the CLIENT or in which the CLIENT may be included, for editorial, trade, advertising and any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. The CLIENT hereby releases Wedding Diary and its legal representatives and assigns from all claims and liabilities relating to said photographs.

ADVERTISEMENT PERMISSION: The use of these images by Wedding Diary is reserved for use in a variety of contexts, including but not limited to social media, print advertisements, internet marketing materials, and other promotional content.

LIMIT OF LIABILITY: In the unlikely event that the photographer is injured or becomes too ill to photograph the event, Wedding Diary will make every effort to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. Wedding Diary takes the utmost care with respect to exposure, transportation, and processing the photographs. However, in the unlikely event that photographs have been lost, stolen, or destroyed for reasons within or beyond Wedding Diary's control, Wedding Diary liability is limited to the return of all payments received for the event package. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals. Due to makeup, dress malfunctions, or any uncomfortable & unavoidable condition, the photographer is not responsible for bad or awkward photographs.

SONG SELECTION FOR CINEMATOGRAPHY: If you are willing to set songs of your own choice, then please upload those song links to our software; if client does not select the songs, the client is requested to send a formal email to set songs of our own choice. In that case, the songs will not be changed.

DELIVERY: You will get all of your deliveries maximum 35-45 working days after your event ends. Within 14 days of delivery, all files will be erased from our servers. So, if you have any complaint or edit, please notify us within 7 days of delivery.

There may be some delay if there are several events of yours, but we will strive to serve you as quickly as possible.

If you are late submitting the music for your event film, your video may be delayed; nonetheless, you must finish all deliverables within 90 days. If you have not collected your images or videos within 60 days, we will erase all data and accept no responsibility.

Therefore, in order to safeguard our mutual interests, we respectfully request that you finish the entire procedure within the specified time frame.
